FINANCE COMMITTEE

September 2016 Financial Statements

Director Peters informed the board that after the fiscal year change, the September financial statements were delayed so NATA could complete an audit on the stub year of April 1, 2016 – June 30, 2016. She noted the timing of NATA's allocations to the districts will not change. She also indicated that there is no need for the districts to modify their fiscal years because of this change.

ATHLETIC TRAINING EDUCATION JOURNAL (ATEJ)

Executive Committee for Education (ECE) chair MaryBeth Horodyski presented the proposed new mission and vision statements of the *Athletic Training Education Journal (ATEJ)*, noting that with the changes in the ECE's work and the growth of the *ATEJ*, the new statements are needed to more accurately encompass the *ATEJ*'s responsibilities.
